Admission Criteria

- 2-3 years over-age for present grade
- At least 16 years of age
- Chronic truancy
- Returning drop-out
- Placement by Directors of Secondary Operations
- Other at-risk criterion as defined by the Texas Education Agency

Success is achieved by students at NTHS when the following information is understood by students and parents:

Curriculum:

- Courses at NTHS are completed on the computer.
- The curriculum is module-based, not time-based.
- All courses are self-paced.

Instructors:

- Certified Teachers are facilitators of the online curriculum.
- Certified Teachers are available for immediate student support.
- Maximum class size is 15 for individualized instruction.

Credits:

- Credits are awarded when courses are completed, not at the end of the semester.
- Completed courses at NTHS transfer to other campuses; *incomplete* courses do not transfer.
- Students are required to complete a **minimum** of *three* credits per semester or *six* credits per year.

Student Responsibilities:

- Student self-motivation and diligent work habits are essential.
- Student accepts ownership and management of his or her individualized education success plan leading to graduation.
- Daily attendance is mandatory.
