551.72 Deliberating the purchase, exchange, lease, or value of real property.

551.73 Discussing negotiated contracts for prospective gifts or donations.

551.74 Deliberating the appointment, employment, evaluation, reassignment duties, discipline, or dismissal of an elected officer or employee.

551.076 Considering the deployment, specific occasions for, or implementation of, security personnel or devices.

551.82 Considering discipline of a public school child, or complaint or charge against personnel.

551.0821 Deliberating a matter regarding a student if personally identifiable information about the student will necessarily be revealed.

551.83 Considering the standards, guidelines, terms, or conditions the Board will follow, or will instruct its representatives to follow, in consultation with representatives of employee groups.

551.84 Excluding witnesses from a hearing.

Should any final action, final decision, or final vote be required with regard to any matter considered in such closed or executive meeting or session, then the final action, final decision, or final vote shall be either:

- (a) in the open meeting covered by this Notice upon the reconvening of the public meeting, or
- (b) at a subsequent public meeting upon notice thereof; as the Security Dept. shall determine.
