Questions	<u>Response</u>
1. In reviewing Figure 1.3, Schedule of Events, we noticed the Anticipated Vendor Award is listed as December 2025, with a Go-Live of All Functionality by July 1, 2026. Given the size and complexity of Garland ISD, this timeline seems extremely aggressive. Can you please confirm if this was a typo, or if the district is indeed aiming to implement all functionality within a six- month window?	1. The July 1, 2026 date is correct. Vendors are required to provide proposals in compliance with this timeline, as well as proposals that detail their best practice for phasing and timing for the implementation based on the scope of the project and the size and complexity of the District articulated in the RFP.
2. In reviewing Figure 1.6, Vendor's Pre-Bid Conference Call, we noticed that the Microsoft teams conference link does not seem to open or link to a Microsoft teams meeting. Can the district investigate, and provide a new link if the existing link is broken?	2. See corrected link in ITEM 2 above.
